President's Report

As my second and final year as President draws to a close, I am proud of the phenomenal partnership between lay leadership and clergy/staff that has enabled the tremendous growth and advancement that BHS has experienced. We have worked together to manage that growth, such that BHS – as an institution and community – is bigger, stronger, and as cohesive and warm and welcoming as ever. Here are some highlights of our journey over the past two years:

My amazing sacred partnership with Rabbi Lippe and Executive Director Sue Gold is the foundation of 'working together'; as important is the partnership in which our broader lay leadership – as embodied in the Executive Committee, the Trustees-at-large, the committee chairs/members – has worked with Rabbi Lippe, Rabbi Kane, Cantor Ayelet, Sue Gold and Pam Karlin and their staffs, all with enormous dedication and the deepest levels of commitment. Specifically, I wish to also acknowledge Director of Member Engagement Amy Leszman, Office and Operations Manager Rebekah Kendall, Executive Assistant to the Clergy and Development Liann Herder, and our facilities staff as led by Erik DiFrisco.

As COVID-19 has presented us with unprecedented challenges in a strange and sometimes scary new world, it should be no surprise that I wish to elaborate first on the last item: our community's strength in this era of physical distancing.

CONNECTING VIRTUALLY

The last year comprised 75% of what I call our 'normal' operations (June through February), then 25% of operating under the strain of COVID-19 (starting in March). We adapted swiftly, nimbly and creatively to ensure that our community could continue to be as meaningfully and richly connected as possible in this new world of virtual communications. Physically, distant; yet, socially and emotionally close. So, what does that mean?

- Our ritual services have seamlessly migrated to livestream on the BHS website and Watch Parties (hosted by Jonathan Kopp – thank you!) in our new Facebook Group, with Rabbi Lippe at the pulpit and Miriam Daly at the piano, enabling us to continue to worship 'together' in familiar and meaningful ways although we are apart. Our BHS Facebook Group has grown from 29 members on March 25th to 225 members on May 4th, and our livestream viewing has increased over 400% since the end of February. A huge note of appreciation to Rabbi Lippe and Miriam Daly.
- Our clergy-led adult ed has expanded to include new Zoom offerings, e.g., Cantor Ayelet's Jewish Music Session, intergenerational Kabbalat Shabbat, Rabbi Lippe's text reading/discussion group, and Student

Rabbi Healy Slakman's Israeli movies discussion. Many thanks to Rabbi Lippe, Cantor Porzecanski, and Student Rabbi Healy Slakman.

- Our Religious School, under the leadership of our Interim Assistant Director Katie Rein, and supported by our Education Program Administrator Céline Alderman, not only migrated our RS learning online, but also created relevant and thoughtful curricula — complete with a committed and organized teaching staff and lesson plans, direct outreach to parents, and, perhaps most importantly, engaged religious school students.
- Our Early Childhood Education offerings transformed to enable our little and littlest ones to remain connected and learning with classmates, and even one-on-one with their teachers. One parent said to me *"the BHS preschool has been a lifesaver!"* Thank you to our Early Childhood Education Director Pam Karlin, supported by Jen Kendall, Lisa Kopel, Melis Bromberg, and our extraordinary teachers.

As one family said, *"We do BHS religious school and preschool via Zoom and it structures our week!"*

BUILDING OUR FUTURE

"New Heights" Capital Campaign

Co-Chaired by Susan Chadick and Dave Smetana, we now have pledges of \$7.2M from 154 donors and the determination and commitment to continue with the Campaign as soon as is appropriate. Anne Landman serves as the Campaign Secretary, as the critical bridge between the Campaign Committee and the Finance Committee. Jonathan Kopp serves as the Campaign's Communications Chair.

Project Management Committee

This committee, co-chaired by Alan Schiffres and Rachel Loeb, with committee members Marcia Bellows, Justin Elghanayan, Barbara Zimmerman, and Sue Gold continued to work closely with our owner's rep Seamus Henchy Associates, architects Sage & Coombe, key staff, the Capital Campaign Committee, Finance Committee, Executive Committee and the Board of Trustees to finalize the construction drawings and project costs so that our vision for our combined building will be delivered on budget and with the high quality we expect. We took the preparatory step of vacating 127 Remsen and moving our clergy suite to One Pierrepont Plaza. However, because construction projects like ours were required to pause during the COVID-19 shutdown, we were unable to start the project as planned this Spring. As a result, we missed the important summer-work window this year. Given this, and the ongoing uncertainty over the next few months, we decided to delay construction until Spring 2021, with project completion now scheduled for summer 2022, a year later than originally planned.

Finance Committee

This Committee, chaired by Treasurer Diego Crasny, with committee members Harry Greenwald, Anne Landman, David Salpeter, Leslie Schultz, and Sue Gold, is building our future as they continue to work diligently on our financing options for our construction project; forecasted, reforecasted and provide oversight for our budget; and, prudently manage our assets and expenses in this new world.

ONGOING MAJOR COMMITTEE EFFORTS

Membership & Engagement Team

Led by Alycia Zimmerman and Helene Fuhrman-Gold, with Lisa Kopel and Amy Leszman as staff liaisons, this team has continued to leverage its extraordinary enthusiasm and creativity to develop strategies and provide engagement opportunities to sustain BHS as a welcoming community for all current and prospective members. Until early March, those opportunities continued to include: Sipping in the Sukkah, Pizza in the Hut, Pop-Up Park Playdates, Shalom Shabbat for our young families, Eat, Pray, L'Chaim, Rabbi Kane's Cooking by the Book, our BHS Men's Group, and, of course, our annual Getting to Know You Dinners. More recently, our virtual engagement has included Trivia Night (with 60 members playing!). Two subcommittees have continued to contribute to our engagement success: the Young Family Committee (Deborah Baruh,

Amanda Miller-Burg, Melissa Dincher, Samantha Hite, Samantha Miller, Kim Rittberg, Dory Weiss, Alycia Zimmerman) focused on the needs and interests of young families, and the Welcoming Committee (Erika Abelon, Deborah Baruh, Joyce Raskin, Kim Rittberg, Vanessa Sussman, and Alycia and Helene), dedicated to ushering new families into our community with intention and attention, with more rigor and vigor.

Lifelong Learning Until March

We offered (and continue to virtually offer) a rich array of lifelong learning opportunities:

- Our *Wise Aging* course, led by Jeffrey Gold, helps participants grow in wisdom, resilience, and spirit through reflective discussions, Jewish text, poetry, and mindfulness practice.
- *Open Heart, Open Mind*, offered by Chair Karen Brody, focuses on addressing family, friendship, health, and thriving as we age.
- BHS at the Movies launched in the Fall, led by former president Melissa Benson. We enjoyed *King: A Filmed Record...Montgomery to Memphis* and *Twelve Angry Men*.
- Tai Chi, taught by member Sandy Wertheimer, had a waiting list to get in!

Social Justice Efforts

Over the last year, the BHS Social Justice Team was led by co-chairs Barbara Arky and Jane Meyers, joined by Linda Feldman, Andrea Feller, Fran Gottfried, Michelle Kaminsky and Stephanie Neville. That team organized our 'Trip to the Border' and our advocacy work with URJ RAC NY.

- BHS 'Trip to the Border:' Led by Rabbi Molly Kane, Barbara Arky and Linda Feldman, a group of 14 people (of all ages, as young as 13), flew to Brownsville, TX and crossed the Mexican border to assist the more than 2,000 asylum seekers living in an outdoor plaza in Matamoros. Thanks to the generosity of the BHS community, sufficient funds were raised to provide dinner and snacks each of the two evenings the group was responsible for meals, as well as provide much needed supplies, clothing and children's books. The BHS group prepped and served the meals, read to, and did art projects with, many of the children, assisted in the medical tent and provided legal guidance. Our gratitude to Sheryl Buchholtz, Bobye List, Roy Walter, Margie Pearce, Matt Rosenzweig, Hallie Rosenzweig, Cliff Fonstein, Lori Hiller, Emerson Hiller, David Arky and Abby Johnson for being our BHS presence in this important work. Also, in support of that effort, Phyllis Starkman and Maureen McLeod led 30 congregants in creating stuffed animals to send to the children in those asylum-seeking families.
- Advocacy with URJ RAC NY: Jane Meyers, along with Fran Gottfried and Andrea Feller, led us in our work with URJ's RAC NY, which each year, with the input of many NY State Reform congregations, selects a state legislative issue which reflects our Jewish values and where we think we can make a difference. This year's bill was the Protect Our Courts Act, which would prohibit ICE agents from detaining immigrants or their relatives in and around NYS courthouses. This year's Social Justice Shabbat featured a speaker from the Immigrant Defense Project who addressed this important issue. Unfortunately, our advocacy on this issue was cut short due to the outbreak of COVID-19.
- BHS Homeless Shelter: We have long been involved in social action, providing assistance to those who are homeless, hungry, or otherwise in need. We run a coat drive, toy and food drives, and participate in other service initiatives. Our homeless shelter, led by congregants Anne Landman and Sasha Burgansky, began its 38th consecutive year of operation, but was temporarily suspended in March. However, we are donating masks, sanitizer, etc. to the social service agency CAMBA – evidence of our ongoing commitment to the homeless.
- Solidarity March Against Anti-Semitism: We marched together as a community on January 5 in the New York City rally expressing solidarity against anti-Semitism, after the numerous anti-Semitic attacks that occurred at the end of 2019.
- Support of an Asylum-Seeking Family and a Refugee: As part of a consortium with Kane Street Synagogue and Congregation Beth Elohim, we are helping support an asylum-seeking family from Chad that has settled in Washington Heights and a refugee from Afghanistan who has settled in Queens by contributing to their living expenses and donating some necessities. Thank you to Judith Winn for her leadership here.

Chesed Committee

Led by Lauren Smetana and Justine Block, this nearly 20-person committee supports community members who might need some extra attention during this COVID-19 crisis as well as those who are home-limited or struggling through other difficult moments. Whether it's ongoing phone check-ins, a meal, a card, a tree planted in Israel, an errand taken care of – the Chesed Committee is on it.

Outreach Call Effort

Led by Interim Board Secretary Monica Elias and member Stephanie Neville, this outreach effort had the objective of reaching every BHS member unit to be a touchpoint and connector during these unprecedented times. As of today, thanks to our 29 callers–Trustees and other volunteers– **100% of our member units have been called.** As one congregant said, *'How lovely to be checked in on.'* That summed it up!

ENGAGING WITH OUR BROADER COMMUNITIES

Interfaith Clergy Service of Remembrance on 9/11

Led by more than a dozen clergy from about ten Brooklyn Heights' houses of worship, we joined in remembrance with our broader Brooklyn community and heard Cantor Ayelet share her moving voice with our neighbors as she led us in *America the Beautiful*.

MLK Weekend with Grace Episcopal Church

Together we commemorated the weekend with our choirs united in song and our communities worshipping together in services held in our sanctuary on Friday night and the church's sanctuary on Sunday morning.

My overarching goal as President was to continue to strengthen the fabric of our community, in large part because I had long felt on the periphery of our community before experiencing more and more 'threads of that fabric.' What I've learned is that these 'threads' are amazing individuals and rich engagement opportunities. Especially now, as we each try to thrive as best as possible in these challenging times, I hope that our BHS community can provide you some grounding now and in the future. You are part of the fabric...and thus make stronger.

Senior Rabbi's Report

Our 61st program year was marked by the crisis and turmoil of the global novel coronavirus pandemic. Without doubt, the synagogue has never experienced such a challenge. And yet, rather than panic or throw our hands up, thanks to the combined efforts and vision of lay leadership and professionals, we have been continuing to respond in real time to the needs of our community.

The report I offer divides between our regular offerings from July 2019 thru February 2020; a review of events in the month of March 2020, and our efforts and offerings from March/April 2020 through May.

I am grateful amidst all that is happening to mark twenty-three years of service as the spiritual leader of the Brooklyn Heights Synagogue. Thank you all for the privilege of service.

We have seen constancy in our staff as well as additions and departures.

Sue Gold, our indispensable Executive Director, returned from a brief mini-Sabbatical in June 2019. In addition to resuming all her regular administrative tasks and oversight, Sue also presented her research and discoveries about her family's Romanian Jewish roots and history.

Our Director of Early Childhood Education, Pam Karlin, continues to guide the school, its faculty, students, and parents with an expert hand and, along with Assistant Preschool Director Jennifer Kendall and Assistant Director of the Parenting Center Lisa Kopel, continues to strengthen and expand our program of family engagement. Thank you to Melis Bromberg, our Coordinator.

Rabbi Molly G. Kane, our BHS Associate Rabbi-Educator, continued in overseeing record enrollment while reviewing, renewing, and expanding our religious education programming. In addition to guiding our religious and adult education programming, Molly brings unbridled energy and vision to our program and community. She also oversees BHS's The Other Friday Night – a Shabbat Experience for Young Professionals in their 20s and 30s. Lena Eson Roe departed from BHS and Katie Rein joined us in March as our Interim Assistant Director of the Religious School. Abby Johnson also departed as our BHS Education Program Manager and Céline Alderman joined us as Education Program Administrator. Both Katie and Céline hit the ground running at full speed and have done an extraordinary job in unplanned for circumstances.

Our Religious School and Preschool once again participated in the UJA Israeli *Shinshinim* (Sh'nat Sheirut – gap year) Program until returning to Israel in March.

Cantor Ayelet Porzecanski joined us in July of 2019 as BHS's first ever full-time Cantor, bringing years of professional experience, strong chanting skills, a pedagogical background, and her beautiful voice to our community. Cantor Porzecanski has maintained and grown our Adult Choir's opportunities to perform for us and in the larger community. She has done a masterful job teaching our 7th Grade as well as providing individual one on one tutoring for all of our upcoming b'nai mitzvah students.

We are blessed that Miriam Daly continues to serve as our Accompanist/Musical Director. Miriam creates and accomplishes tiny unnoticed musical miracles every time she is at the piano. She leads a terrific band and has been a talented rehearser for the choirs.

Rabbinic Student Healy Slakman continued in her role providing introductory prep tutoring for our many students, teaching in the religious School, and leading grade services, as well as our young professionals The Other Friday Night services.

Liann Herder continued as our Executive Assistant to Senior Clergy and Development and has made an outstanding impact upon our synagogue community and organization.

From November through February, we saw packed family attendance and participation once a month at our

Shabbat B'yachad grade family service and dinner thanks to Rabbi Kane's planning, Lena Eson Roe's attention, Abby Johnson's excellent execution of planning, Student Rabbi Healy Slakman's leadership, vision, and energy, Cantor Porzecanski's willingness to jump in, and thanks to the assistance of Miriam Daly providing her musical talents.

At weekly worship services, we announced the coming of the new Hebrew moon each month, continue the custom of Counting the Omer, and blessed congregants' numerous simchas and publicly recognized good tidings on one Friday of each month. And we have named numbers of infants, children of members, and our neighbors on many Friday evenings. We celebrated festivals and holidays, minor and major. We celebrated births, namings, birthdays, conversions, weddings, anniversaries, and other simchas in our sanctuary and elsewhere. We worried and prayed through sickness and adversity.

Saturday morning Chavurah continued to grow and prosper under myself, Rabbi Molly Kane, Rabbi Daniel Lehrman, Rabbi Sue Oren, Rabbi Sonja Pilz (a new gem of a find!) and Student Rabbi Healy Slakman, our rotating pool of facilitators. Thanks to lay prayer leaders and facilitators David Hirschland, Ken Roff, and Laura Szapiro.

BHGSY, under the leadership of the BHGSY Board, its co-presidents Maya Kendall and Zoe Mardiks, and Advisor Jenny Singer, offered wonderful programming to our youth and the congregation as a whole.

BHS is held together by the regular ongoing and outstanding work of committees like the Chesed Caring Committee that touches so many of us individually (thanks Justine Block and Lauren Smetana), the Ritual Committee (thank you Jeremy Primer), the Religious School Committee (thank you Liz Mayer), and the College-In-Touch Committee (thanks Ross Brown and Lisa Securo), and the Preschool Committee, the Shelter Committee and THANK YOU to all the members whose names aren't printed here but are the glue that we depend upon.

The Social Justice Committee has been hard at work under the leadership of Barbara Arky, Linda Feldman, and Jane Meyers.

Judith Winn, and others have been supporting our involvement with the Brownstone Brooklyn Synagogue Coalition for Refugees. We are participating right now in work with HIAS to support a local asylee from Chad.

A great deal of my time, attention and energies before March had been devoted to the planning and oversight and individual solicitations for our "New Heights" Capital Campaign. Many thanks to co-chairs Susan Chadick and David Smetana, and to Anne Landman, our Campaign Secretary, as well as to all our solicitors, and to Liann Herder whose long title only hints at her work for Development at BHS. Many thanks to Project Management Committee Chairs Rachel Loeb and Alan Schiffres and all the members of that extraordinarily hard working and important committee.

We call to mind the passing since last year's annual meeting of BHS members Martin "Marty" Adelman, Alexander Berger, Claire Pemstein, Sylvia Rosenberg, Edward "Ned" Sack, Philip "Phil" Schneider, and Marvin Starkman. A loss of a generation and of communal memory.

Far too many of us lost a parent, sibling, or close friend in this past year.

Both in adversity and in celebration, we at BHS have buoyed each other up and offered the hand of comfort.

Our youngsters learned in our religious school, and at Parenting Center programs and family education programs. Our well-attended Tot Shabbat program continued to be led by Lauren Demby.

My Welcoming Shabbat program on Friday mornings continues to bring young families and potential new members into early affiliation.

Under the leadership of Alycia Zimmerman, co-chair of our Membership and Engagement Team, we have introduced a new brief Shabbat Evening service entitled Shalom Shabbat: Young Family Fridays at BHS at 5:30pm each quarter.

Early Childhood Education Director Pam Karlin and Assistant Parenting Center Director Lisa Kopel coordinated a variety of holiday and life-cycle related programming (Bagels & Blocks) for this youngest age range that is open to the entire community.

Programmatically, through February, it had been a remarkably busy and exceptional year.

Thanks to Cantor Porzecanski, Rabbi Kane, and David Jaroslaw who along with me led summer services in 2019.

Tisha b'Av was organized by Rabbi Kane and Cantor Porzecanski on August 10, 2019.

On September 11, we gathered on the Promenade with Brooklyn Heights Interfaith Clergy Association to mark this day of tragedy and memorial.

We prepared for the Days of Awe with Selichot services on Saturday evening, September 21. We gathered for Rosh Hashanah eve at Plymouth on Sunday evening, September 29. In between Rosh Hashanah and Yom Kippur on Sunday, Sue Gold organized our efforts to beautify the synagogue's cemetery section and bury our tattered sacred texts at Maimonides Cemetery. Many thanks to our volunteers.

On Yom Kippur, Tuesday evening October 8, we were again inspired by our choir. And we heard moving Spiritual Journeys from our fellow members on Yom Kippur morning: Jennifer Epstein, Matt Baer, and Cantor Ayelet Porzecanski.

We celebrated Sukkot with our outdoor sukkot, including the large Sukkah in the backyard of 127 Remsen Street, as well as in the sukkot of many of our congregants. We consecrated new students in our Religious School program. We danced on Remsen Street with the Torah Scrolls accompanied by our Klezmer band, Klezmer Connection, once again on Simchat Torah.

On Friday evening, November 15, we observed the first anniversary of the tragedy at Tree of Life Synagogue in Pittsburgh and gathered as a community for #ShowUpForShabbat. We saw the support of our neighbors and all the other Houses of Worship in our community to stand fast against anti-Semitism and hate.

Rev. Brett Younger (of Plymouth Church) and I swapped our pulpits for sermons over the summer, and we also had a number of interviews on radio and video, addressing the surge in antisemitism around the world, USA, and here in NYC and in Brooklyn.

Even before the pandemic, the world around us had turned darker and stormy, but we endeavored to remain both confident in our Jewish commitments and ever vigilant.

Both on the High Holidays at Plymouth and in our own sanctuary on Shabbat, we worshipped and celebrated with those present and those not present, through the livestreaming of our services over the internet. We continued with visual *tefillah* on most Friday evenings, projecting the words of the prayers up on the front wall of the Sanctuary during most Friday evening *Shabbatot* from September through early March.

I also offered and taught a number of Adult Education classes as well as Adult Intermediate and Adult Advanced Prayerbook Hebrew.

Our BHS Homeless Shelter continued to meet the unfortunate need and reality of NYC for its 37th year, until the coronavirus pandemic forced us to suspend our shelter services in March. Thanks to all our lay coordinators and volunteers. It is one of our most significant undertakings and it is all done by the laity of the

congregation. You inspire me and the rest of the clergy team and staff!

In December, I and many members attended the URJ Biennial in Chicago. I was privileged to join our incoming President Marcia Bellows as part of a panel presentation on Mutual Review thanks to our efforts here at BHS.

On December 20, we celebrated our 60th year of worship services (December 25, 1959/1st Eve Chanukah was our first ever service as a congregation over at First Unitarian!). We kindled a beautiful Shabbat Menorah and members of different generations recounted our congregation's unfolding and on-going history!

In January, Rabbi Kane led a truly remarkable trip of our members to Brownsville, Texas to assist the asylum-seekers trapped on the other side of the border in Mexico. *Yesharkochachem!*

On Sunday, January 5, BHS participated in the Solidarity March Against Antisemitism "No Hate, No Fear," marching over the Brooklyn Bridge and gathering as a congregation at the World War II Memorial at Cadman Plaza Park.

Once again, we celebrated Dr. Martin Luther King Jr.'s birthday weekend with joint choir performances and sermons, this year with Grace Episcopal Church. Rev. Allen Robinson preached on Friday evening at BHS and I offered a sermon at Grace on that Sunday morning at their worship service. Thank you to Cantor Porzecanski and Grace Church's Paul Olson and all the members of both choirs for very powerful presentations at those services.

On that Saturday, January 18 we screened the film [KING: A Filmed Record](#) in our sanctuary for both congregations – thanks to Melissa Benson and Robert Boyd.

We re-met each other at the hugely successful Getting to Know You Dinners at the very end of the month on Saturday evening, January 25.

In February, we were once again joined by Israeli Rabbinic Student Osnat Eldar, a Gold Fellow from HUC-JIR Jerusalem who lead a number of classes and our Tu B'Shevat Seder on Monday, February 10.

In February we also undertook efforts that resulted in our hiring Katie Rein as our Interim Assistant Director of the Religious School and Céline Alderman as our Education Program Administrator starting in March. Little did they or we know what would be asked of them as they stepped into their new roles with us at BHS.

On Thursday March 5, the Preschool held its 18th annual Spring Benefit at the "other" BHS – the Brooklyn Historical Society. It was an amazing and energetic success!

On Sunday, March 8, I lead our annual Tot Megillah reading followed by an absolutely terrific Carnival, with many, many thanks to all the volunteers for the fun!!!

Later that evening, Rabbi Molly Kane and her wife Michelle Citrin welcomed their son Avishai Lev Citrin-Kane to the world! Rabbi Kane is on a well-deserved maternity leave through early June.

The next evening, Monday, March 9, a large contingent of members once again chanted from the Megillah aloud followed by our Purim Shpiel created by the Cantor from the hit movie "Frozen."

On March 11, the World Health Organization declared the novel coronavirus a global pandemic. We had already begun to pivot our programming a week prior. On March 12, our Executive Director Sue Gold emailed the first of several detailed updates about our plans moving forward in the new circumstances, including an initial two-week hiatus that began on March 15. By our March 18 Board of Trustees meeting, the difficult decision was made to close the homeless shelter. We either rescheduled, delayed, or cancelled

programs as appropriate. We quickly adopted a professional tier and secure version of Zoom for meetings, programs, and educational programs to continue. Our very last bat mitzvah was held in the Sanctuary on March 21 with the bat mitzvah, her sister, mother, father, Miriam Daly and me. Following the Mayor's directive to stop worship in Houses of Worship in NYC, all other spring b'nai mitzvah were put on hold and have been rescheduled for the fall.

Although we cancelled the annual Women's Seder, we decided to host a congregation-wide Zoom second-night seder that saw about 75 families participating. In addition to live-streaming festival services on the first morning, seventh evening and seventh morning (with Yizkor) and creating all the various PDF services to download or screen share, the Cantor also offered a Zoom Yizkor at noon on the seventh day of Passover.

The week after Passover, we observed the community-wide Yom HaShoah via Zoom with Park Slope Jewish Center and Kolot Chayeinu and all of the synagogue cantors leading us. At BHS we observed Yom HaZikaron (Israel Memorial Day to Fallen Soldiers and Victims of Terror) as part of the shiva minyan for Sue Gold's dad, Len Greenberg. We have become adept at Zoom shiva minyanim, generating the necessary PDFs for downloading or screen-sharing.

In addition to offering a sermon each Friday evening addressing both Torah and current concerns during the pandemic, I have offered several independent video messages to the congregation on the homepage of our website.

As a professional team, we have organized and offered a remarkable set of continuing education offerings on a daily basis via Zoom, from meditation and yoga, to Jewish music and movies and cooking, to sacred texts and Hebrew. Every member of our team has stepped up repeatedly to connect and engage with our community. *Yesharkochachem!*

On Zoom, I continued to mentor a number of students (some congregants) seeking to become Jews by Choice, a tremendously time intensive but rewarding process.

In addition to my regular 10th Grade/Confirmation Class teaching role, I continue to offer 11th and 12th Grade over Zoom twice a month, which sees our students continue on beyond Confirmation in their studies.

It is with heartfelt regret that the URJ recently decided to suspend our nationwide summer sleep away camps including Crane Lake and Eisner. Likewise, the URJ NFTY in Israel travel program is suspended this summer. We hope and pray that all these programs will be restored for the summer of 2021. Likewise, our BHS 9th grade class trip to Israel in May has been cancelled with the hope and expectation that we will be able to take both our 9th and 10th graders next year.

A big shout out THANK YOU to the special group of congregants who stepped forward previously to help the congregation and Board keep its commitment to this program by donating the dollars to keep this program afloat over the next several years. It is an extraordinary pledge of dedication!!!

Executive Director's Report

"We are all in this together" has become the message of the day, it seems, and rather than use this opportunity in the Annual Report to the Congregation to reflect upon the past year as I typically do – all the programs, events, life cycles, administrative improvements, security grants awarded, campaign initiatives, building project updates – or to imagine what the coming year will be like and to share some of our plans and expectations – I am living very much in "this" moment. I think many of us are.

This. This life we are all currently living in the era of COVID-19, struggling with it, suffering, too. Juggling work life, home life, school life – all under one roof. Worrying about our children and what is ahead for them, concerned about screen time and loss of summer camp plans. Working hard in our home offices or concerned about sustaining our work, possibly losing our work. Worrying about our parents and other elders and our friends, and our friends' parents and elders. Being completely isolated if we are living alone and not well. Stressing over supermarket runs and endlessly washing our hands and our face masks. Trying to stay hopeful and careful. Navigating Zoom and joining in social and educational gatherings and joining in for virtual Shabbat. Trying to get some fresh air each day. Wondering when "this" will end and what "that" will look like. For right now, we are all in "this" together. Living with "this."

And, yet, there is another "this" that we are all in together, and that is the BHS community. It has been remarkable – and palpable, even remotely – how strong the BHS community has been through this crisis. As Rabbi Lippe's report shares here, this has been a busy and successful year at BHS, and our community continues to come together in vitally important ways to learn, to worship, to support, and to begin to plan for the time when we will be together again physically. Our Chesed Committee, under the extraordinary leadership of Justine Block and Lauren Smetana, have kept in regular touch with our homebound seniors and single members with health issues, making sure they have what they need to get by, calling to say hello, to send virtual hugs and support, to shop for medicine and food. Members of our Board of Trustees, along with many dedicated volunteers, coordinated by members Monica Elias and Stephanie Neville, have been calling and checking in with every other household in our BHS community, and – to date – 100% of the community has received a call – truly astonishing. Our dedicated Religious School Education team and teaching staff and our creative Early Childhood Education team and teachers took almost no time at all to transition both schools to virtual platforms, creating a schedule of interactive and stimulating curricula for our students and providing support, as well, to our young parents, whose homes have become virtual satellite early childhood centers. Read their reports and be proud, as I am. Our Administrative team and key lay leaders (shout out to Jonathan Kopp for hosting the Friday Night Watch Party each Shabbat on Facebook!) nimbly finessed all of the technological complexities required to build and promote our virtual gathering spaces for worship and learning, all while continuing routine business office operations. Our Clergy team – superheroes all – have reimagined and delivered Shabbat and holiday services in this virtual world, and have created new educational and gathering opportunities for children, families, adults of all ages, all while continuing to provide extraordinary care and attention to the many lifecycle needs of the congregation. And, while all of "this" life goes on virtually, our physical facility has been thoroughly disinfected and cleaned, top to bottom, repairs and inspections completed, so that we can return the moment we are able – to school, to worship together, to our treasured community gatherings.

When my father became gravely ill and passed away on April 20, in the midst of the COVID-19 pandemic, my greatest fear was that his suffering and my family's grief would be solitary. Instead, the message I heard from the BHS community was "We are all in this together, with you." And you were. This BHS community showered me with calls and cards, texts and tributes, Facebook messages and food in such abundance that I could actually feel your embraces tighten around me, holding me up, helping me through. I received cards from young children, with their beautiful drawings and words of love splashed across the colored paper. This is who you are; this is what you teach your children; this is what you do – not just for me, but for each other. I see it all the time. You are present when it matters most of all. "*Hineynu*," you said. We are here. We are all in this together.

As we look forward to the coming year, aware that much uncertainty still lies ahead, let me encourage you to redouble your commitment to BHS, renew your membership, sustain your support so that we can continue on the amazing trajectory we have been on, even through this most challenging time. And, just as you have been here for each other and for us, we will be here for you. *Hineynu*.

I'd like to extend my deepest gratitude to Karen Gordon, the Executive Committee, and the Board of Trustees for their extraordinary leadership over these past two years. Karen, it has been a profound honor to serve as one of your sacred partners in advancing your creative and transformational agenda. Your report reminds us of how much has been accomplished and BHS will be forever grateful. I look forward to serving alongside Marcia Bellows whose love for and commitment to BHS runs deep and strong. Treasurer's Report

Overview of the Current (2019-2020) Fiscal Year

On March 31, 2020, we had cash balances in operating accounts totaling \$1,795,568. The capital campaign account balance was \$1,593,035. Restricted fund account balances totaled \$146,002. The outstanding balance on the mortgage is \$719,814.

As of March 31, 2020, the end of our third quarter, using cash basis reporting, revenues were \$2,886,161 and expenses were \$3,049,240 leaving us with a deficit of \$163,079. This compares to a surplus of \$166,062 at the same time last year. Before the COVID-19 crisis hit, our initial reforecast for the fiscal year ending June 30, 2020 showed a surplus of \$46,000 vs. our original FY 2019/20 budget surplus of \$3,000. This forecast is now in question and unlikely to be met, given the possible impacts of the current COVID-19 situation on our revenues. Meeting our forecast and our FY 2019/20 budget will depend on the collection of Membership Dues and Tuitions (Preschool and Religious school) during the period May to June 2020.

The primary reasons for this year's weaker performance vs budget and vs last year are:

- Revenues for the Preschool are lower than a year ago and also below budget. Since we are still reporting on a cash basis, significant prepayments received in the prior year for this school year were booked last year. This has not happened to the same extent as of March 31, 2020.
- Revenues for the Hebrew School are at 54% of budget, when they should be at 75% at this time of the year. This is due to lower enrollment than projected and to a slowdown in collections.
- Although expenses are on budget as of March 31, 2020, they have increased significantly compared to last year, mostly driven by higher personnel expenses.

Capital Accounts and Capital Campaign

As of March 31, 2020, the cash balance in the Capital Campaign account was \$1,593,035 and the balance in the Weissler endowment fund was \$450,609 (which has been designated by the Board for building expansion).

Capital campaign donations and pledge payments received through March 31, 2019 totaled \$1,926,944 and expenses were \$922,235.

As of today, we have commitments totaling \$7.2 million for our New Heights Capital Campaign against our goal of \$9.5MM.

Budget for FY 2020/21 (July 1, 2020- June 30, 2021)

Starting with the FY 2020/21 operating budget, we will report and budget on an accrual basis rather than on a cash basis.

An initial budget prepared and presented in draft form to our Board of Trustees showed a very small surplus and included assumptions about growth in membership, dues and tuition increases as well as fundraising goals, and expense increases that are no longer realistic or possible. A revised budget was prepared to include the potential impacts of the COVID-19 crisis. This revised budget was approved by the Board and is being presented to the congregation tonight even though there is still much uncertainty surrounding the impact of the COVID-19 crisis on our revenue stream. It is our best attempt to predict the financial performance of BHS, when there are still so many unknown factors.

The current FY 2020/21 budget shows revenues of approximately \$3.8MM and expenses of \$4.1MM, for a potential deficit of ~\$300K.

The key assumptions in this FY2020/21 budget are:

- Donations and Fundraising are shown as lower than in FY 2019/20

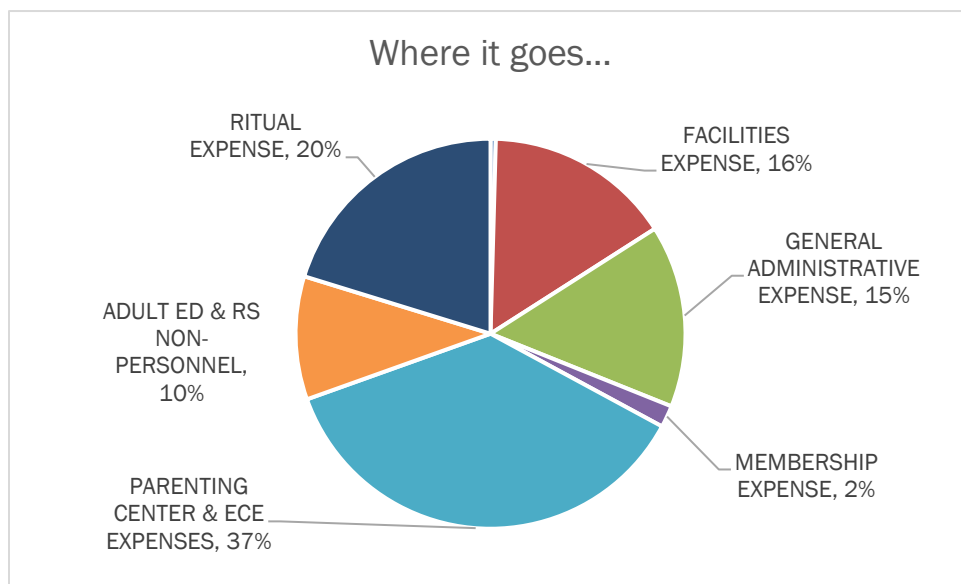
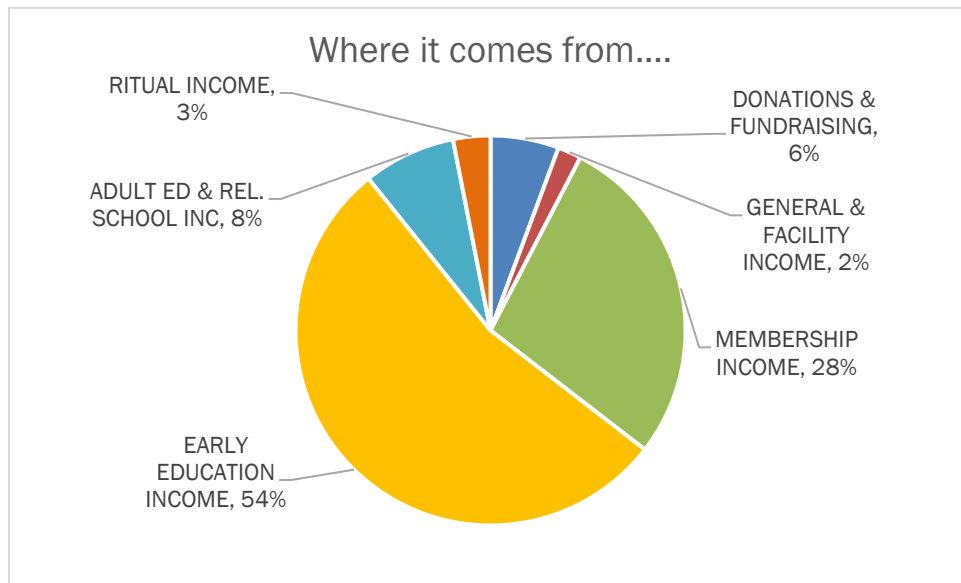
- No increase in membership dues (as opposed to a 4% increase in prior year) and the number of membership units remains constant
- The Preschool would be open at current tuition levels, but we show a reduction in revenues from Summer Camp and other preschool programs
- No increase in Hebrew School tuition and we show a decrease in the number of students
- No reduction in staff and no salary increases for staff

A loss of \$300K in FY 2021 is not a desirable outcome for BHS. Efforts will be made to reduce or eliminate this deficit, by applying very strict cost reduction measures that go above those reflected in this budget, possibly by increasing dues by a nominal amount, and by asking those members who are still financially able, to continue their very generous support of BHS not only by paying dues and tuition, but also by making additional donations as you have done in the past. We recognize that many members are experiencing financial distress from lost jobs and/or salary cuts. We will continue our longstanding policy of providing financial accommodations for members in need.

Withstanding the COVID-19 Crisis

With that in mind, we applied for and received a Paycheck Protection Loan from the Small Business Administration in the amount of \$449,000 at 1% interest. We will do everything we can to fulfill the ever-changing requirements established by the government to obtain forgiveness of this loan.

Other matters

The FY 2019/20 financial statements will be prepared in accordance with US GAAP, and following the accrual basis of accounting. This will allow for a more appropriate presentation of the BHS financial data this year and going forward. In addition, our financial statements will be audited this year.

Michelle and I feel incredibly blessed that Avi is healthy, strong, and growing every day. We love his sweet sounds, the look in his eyes as he takes in his surroundings, and his adorable smile. Since he was born, we have developed the ritual of tuning into BHS Shabbat services, singing to Avi the prayers and melodies that are so familiar to us, and then Michelle and I have the privilege as parents to bless Avi at our Shabbat table...it is one of the holiest moments of our week.

Cantor's Report

It is hard to believe that almost a year has passed since I joined Brooklyn Heights Synagogue. It has been an exciting, fulfilling year. Becoming part of this lovely, vibrant community continues to be a blessing.

I would be remiss if I did not also thank the Torah and Haftarah readers by name, who chanted High Holy Day cantillation beautifully, some for the first time! Thank you to: Matt Baer, Leo Gordon, Naomi Jaroslaw, Miriam Katowitz, Jack Kramer, Rachel Landman, Michael Landman, Mark Landman, Michael Lippe, Risa Lippe, my son Rafael Piatigorsky, Jeremy Primer, Sam Richardson, Ben Schak, Rachel Schnoll, Ariel and Flora Schwartzman Miles, Jennifer Zaslow, and Alycia Zimmerman.

Thank you also to my son Rafa for blowing shofar for the children's service.

Other highlights in September include blowing shofar for the Preschoolers and helping one of their classes install a *mezuzah* on their classroom door!

October saw the completion of the High Holy Days. There had been a bar or bat mitzvah every Shabbat since the first week of September, and in October the celebrations continued! Each Shabbat welcomed an accomplished and confident youngster to our *minyan*.

Rabbi Lippe and I launched our program for incoming b'nai mitzvah families, including a mock shabbat where parents could ask questions throughout the "service" and upcoming b'nai mitzvah stepped up to help lead the "service". I began teaching in the Hebrew school, teaching 7th grade cantillation and Hebrew. The 7th graders were divided into three classes to accommodate their numbers.

Our festivities continued with *Sukkot* services and *Simchat Torah*. I shared some of *Megillat Kohelet* - and found willing volunteers to chant Torah. Many thanks to Mark Landman, David Jaroslaw, Deb Speyer, Risa Lippe, and Matt Baer for ending our Torah, and beginning it again!

Another highlight of October was collaborating with the 7th graders for their Shabbat B'yachad service.

In **November**, the Shir Shabbat band began joining us for Friday night service. They played every third Friday, and their first for the year was in November. It was #ShowUpForShabbat night, followed by a community dinner. They adapted to the service changes needed to welcome several guest clergy to the *bimah*, and greatly helped to make the service moving and joyful. Many thanks to the members of the Shir Shabbat band: Eve Hall (flute), Dan Shacknai (clarinet), Roy Walter (guitar), and his son Jason (violin) who joined us when he was home from college.

Also in November, I taught a *Zemirot* class in 3 parts, about the songs sung around the dinner table on *Shabbat*. It was well attended and received. I shared some of the material from the class with the Friday night community on Thanksgiving *Shabbat* when I gave a "d'var shir."

A highlight of November was the first meeting for the cantors, rabbis, and educators of the downtown Brooklyn area, and our new *Shlichut*, Tomer Gekler, that I hosted at BHS to kick off planning for community Israel events in the spring.

In **December**, I was privileged to experience the URJ Biennial for the first time. I am grateful to have been sent, and grateful to Rabbi Lippe for splitting the time with me so that I could attend over Shabbat. I was able to spend some quality time with our synagogue leadership and hear the newest music and ideas that URJ cantors have to offer. A change that came out of the convention is that we licensed all the music we use for services so that composers get the compensation they deserve for their work. Deep gratitude to Fran Gottfried for underwriting this expense!

The third Shabbat in December I gathered some willing members of the choir and the Shir Shabbat band to help us celebrate 60 years of BHS, Chanukah, and the parshah (the Joseph story). The choir and band collaborated thanks to Miriam Daly arranging the choir's music for the band. During the service we shared songs of Chanukah, community milestones, and Joseph!

I wished my Hebrew school class a sweet Chanukah with songs and a parting gift of gelt!

The highlight of **January** was the Rev. Martin Luther King Junior weekend. This year, First Presbyterian Church of Brooklyn had alternate plans for their celebrations. On Rabbi Lippe's suggestion, I approached Grace Episcopal Church who were thrilled to share MLK weekend with us. Our choirs rehearsed separately then together for the occasion, joined together on Friday and Sunday, sharing music from both our repertoire. I was thrilled to be honored at Grace Episcopal Church by also being asked to sing for their service. Our Shir Shabbat band joined again for Friday's service, and we had a packed house and joyous

community dinner. Once again, Miriam Daly wrote arrangements of all the music for the band, which played beautifully.

Miriam and I recorded all the songs of the Saturday morning service, and I created a page with the music, Hebrew, transliteration, and translation for families to familiarize themselves with the service music. Thank you to Michele Jaslow for her work to make this all real on our website!

The b'nai mitzvah celebrations picked up again weekly after a break during the school holidays, and there were more than 27 children coming through my office for lessons each week. Many thanks to Healy Slackman who teaches the children their prayers. She added extra time to her already busy schedule to help with the volume.

In February, Prohibition came to BHS in the form of a Havdalah Speakeasy night! I collaborated with Andy Akers and Jennifer Wilkov to host the evening and recruit artists to perform. Visiting Rabbi Osnat Eldar from Israel co-lead Havdalah with me, and congregants performed music, poetry, and theater for each other while Jennifer emceed and shared about the history of speakeasies. A fun night was had by all!

I completed my semester of teaching the 7th grade and began teaching 6h graders with upcoming b'nai mitzvah. Other highlights include the Shir Shabbat band once again on the third Friday of the month, rehearsals for our Purim Shpiel began as I recruited *Megillat Esther* readers, and we packed up 127 Remsen and moved out!

In **March**, we learned how to turn on a dime!

The month began with Purim: I coordinated and supported the readers of the Megillah, some who were chanting this special cantillation for the first time! Many thanks to the chanters: Bette Birnbaum, Jessica Brown, David Jaroslaw, Rabbi Sonja Pilz, Jeremy Primer, Dan Rosenbaum, Student Rabbi Healy Slakman, Laura Szapiro, Vanessa Wise, and Zeke Wise.

The Purim *Spiel* was "A Very Frozen Purim" starring Ross Brown, David Hirschland, Max Leighton, Ellen Rittberg, Tobin SecuroBrown, Olivia Sohmer, and Sandy Wertheimer! It was replete with favorite song parodies from both Frozen movies and Miriam accompanying on piano.

Our ranks grew by one as I hired HUC rabbinical student Peter Young to supplement teaching prayers on Sundays to our B'nai Mitzvah in response to the volume of children in the spring. We are thrilled to have him on board helping us out.

Another highlight of March was being a guest at the annual Preschool Benefit at the "other BHS" (Brooklyn Historical Society). I was thrilled to be able to welcome parents and thank Pam for her amazing leadership.

Shortly after Purim we became remote overnight - I began offering a Wednesday music class, featuring yiddish song, sephardi song, songs of Israel highlighting composers such as Naomi Shemer. I offered a Friday service for families of all ages with music and a parshah sermon at 5pm with over 30 families connecting on Zoom, and the help of my son, Rafa, and accompanying myself on guitar.

We had to postpone (date TBA) a Cantor's concert that was to be held at the end of March, where the choir would have sung, and the Women's Seder, which I was set to lead in collaboration with Michelle Citrin and Rabbi Sonja Pilz. In addition, all the plans for several joint Israel events across Brooklyn (including a cantors' performance of Israel songs on *Yom Ha'atzmaut*) were put on hold.

I continued to meet with b'nai mitzvah over the phone and supervise the tutoring of them under Healy and Peter. I track the attendance and the progress of over thirty individual weekly appointments.

In **April** Passover came, and the advent of the Zoom seder! Our offerings for the community for Passover were many and rich. I led a Passover morning service with Rabbi Pilz, including the special blessing for dew (*Tal*). On the second night of Passover Rabbi Lippe, Rafa and I led a seder that was attended by over 70 families. It was very well received, full of song and joy.

On the seventh day of Passover, I supplemented Rabbi Lippe's morning service by offering a musical *Yizkor* service.

Another highlight of April was collaborating with Cantors and Rabbis across Brooklyn for a Zoom *Yom Hashoah* (Holocaust remembrance) service.

May-June:

The rest of the spring I have intentions to continue my current offerings, bring together those who wish to learn Torah for Zoom classes, and connect visibly with more musical Videos. I hope to continue to support the Rabbis in their tireless work as we plan for the fall.

I cannot finish this report without thanking the BHS staff (in addition to the wonderful Miriam Daly). I want to be sure to mention specifically our Executive Assistant to the Senior Clergy and Development, Liann Herder, whose help to me is so vital. Thank you also to Amy Leszman for talking me through the membership list and events to help me know BHS better. Thank you to Sue Gold without whom none of this would be possible, and to Rebekah Kendall for her support. My gratitude to Rabbis Lippe and Kane for their collaboration, good humor, and wisdom. And, of course, to all the lay leadership who have made me so welcome here. Among them are the members of the Cantor Search Committee, chaired by Michael Lasky, and members of the board, especially Karen Gordon, who's incredible leadership has been a gift.

Most importantly I want to thank my family - my children Rafa, Anatalya, Jordan, and Chloe who work hard at their own endeavors and pursue their own dreams with passion, and my husband, Aric, who keeps the entire boat afloat. Thank you to the BHS community for welcoming me - I look forward to what we can create together!

Interim Assistant Director of the Religious School's Report

The Brooklyn Heights Synagogue Religious School (BHS RS) welcomed 30 teachers, 235 students, and 162 families to its program this year to celebrate Jewish life, rituals, and family engagement. Together with a staff of 30 Teachers, 12 Madrichim, 2 Musicians from Tkiya (participatory Jewish music experience program,) and 1 Israeli *Shinshin* (Israeli emissary for the year,) the BHS RS created an enriching program around classroom *Brit Kehilah's* (policies) and *Kehilot Kadashot* (holy communities).

The BHS RS ran in person learning Sundays - Wednesdays from September 2019 until March 2020, and virtual programming from March 2020 - May 2020 due to COVID-19. The BHS RS transitioned to virtual learning starting on Sunday, March 15, 2020. From Sunday, March 15, 2020 to Sunday, March 22, 2020, teachers created lesson plans which students could implement individually at home. Beginning on Monday, March 23, 2020, the BHS RS was fully online, supporting students on virtual Zoom classes. Virtual classes were held at the regular RS times (Sunday 10-12, M/T/W 4-6PM and Hebrew High on Tuesdays from 6-8pm) and split up into four sections:

1. Schoolwide music/*tefillah* lead by Healy Slakman, our Student Rabbi and Ran Livneh, one of our Friday night musicians
2. Check-in's with the students
3. Judaics
4. Hebrew

Over the course of the year, Rabbi Kane and the Assistant Directors (Lena Eson Roe and Katie Rein) worked closely with the Religious School Parent Committee, Brooklyn Educators Network, and teaching staff to create engaging programs, incorporating feedback from parents, families, and teachers.

Curriculum

The curriculum weaves together several strands of Jewish learning at each grade level:

Ritual: holidays, prayer, tradition, and modern meaning spirituality and exploration of theology

Hebrew: comfort participating in progressive Jewish settings by decoding Hebrew and understanding Jewish terms

Israel: the people, the land, the state, the culture, and Hebrew as a living language

Social Justice: *Tikkun Olam* (repairing the world) as collective action and *middot* (personal good deeds) as internal practice

Arts and Exploration: exploring Jewish ideas and

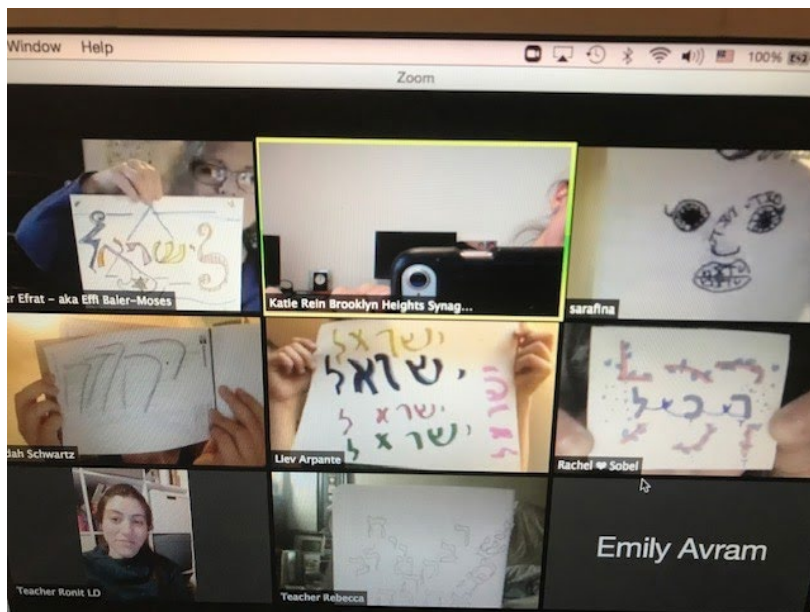
life through visual arts, dance, text, and hands-on exploration of New York City's Jewish heritage

Imagination and Creativity: envisioning a Jewish future together in our nesting communities: family, class community, synagogue, Israel, and *K'lal Yisrael* and the world.

RS Enrollment 2019 - 2020

- 235 students total
- 57 students in K-2
- 30 students in 3rd grade
- 76 students in 4th-6th grade
- 30 students in 7th grade
- 42 students in High School
- 12 *madrichim* (post b'nai mitzvah Religious School helpers)





Both the Judaics and Hebrew curriculums included differentiated lessons to meet student's needs. This year we had two native Hebrew resource teachers, Shiraz and Yechiel, providing Hebrew help to teachers and pulling students out of the classroom to work one-on-one both in person and virtually. Hebrew curriculum includes Hebrew Through Movement, "a language acquisition strategy in which students learn Hebrew by hearing and responding to Hebrew commands," *Mitkadem*, "a self-paced Hebrew prayer and ritual program designed to empower every child to learn Hebrew" from Behrman House Publishing and Shalom Hebrew Workbook.

Madrichim

Our madrichim program, where students serve as teacher assistants in our religious school classrooms, included 12 students who earn an Amazon gift card as compensation for each semester they work. BHGSY flourished under the leadership of our students with supervision and mentorship from our Youth Advisor Jenny Singer.

Lifelong Learning

- The Other Friday Night: Led by Student Rabbi Healy Slakman and Rabbi Molly Kane, 15-35 people when celebrating Shabbat in person, when celebrating virtually over Zoom in April there were 15 people.
- Karen Brody's class, Open Heart, Open Mind, has 10 members
- Jeff Gold's Wise Aging class had 12 participants
- Sue Oren's Introduction to Judaism begins early May for Spring/Summer session, Virtual Meditation on Tuesday mornings
- Adult Hebrew: Continues to meet virtually with Rabbi Lippe
- Chavurah: Continues to meet virtually with a host of our leaders!
- Cooking by the Book: Student Rabbi Healy Slakman successfully hosted a virtual Cooking by the Book Shabbat lunch in March after Rabbi Kane led a Cooking by the Book session earlier in the year
- Movie Discussions with Student Rabbi Healy Slakman: An article in The Jerusalem Post recently identified the Top 10 Israeli Movies of the Decade. The movie changes weekly, then all tune in together to discuss culture, identity, history, aesthetics, and more.

We, Katie Rein, Interim Assistant Director and Céline Alderman, Education Program Administrator joined the team full time at the end of the February and beginning of March and are a grateful dynamic duo leading the Religious School through this new era.

Director of Early Childhood Education's Annual Report

THE 2019-20 SCHOOL YEAR

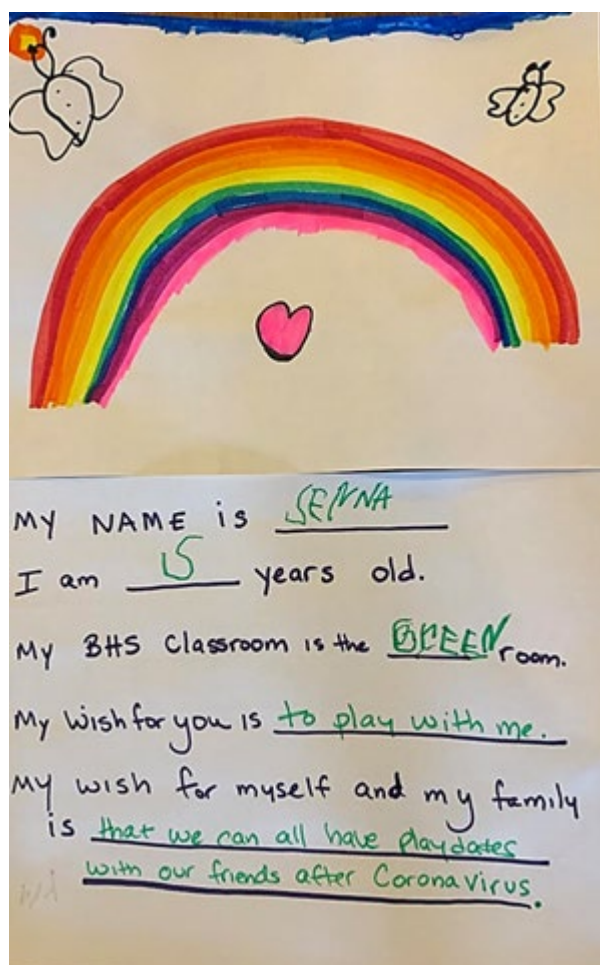
This year the Preschool had 102 students in seven classes and celebrated its eighteenth year of working with children and their families in the Brooklyn Heights community. From September to early March, we enjoyed our usual calendar of meetings, emergent curriculum that followed the interests of our children, celebrations, and a bevy of choices and electives for children and their parents. While this year is likely to be defined in our memories by the changes required because of COVID-19, we also cherish this year and its accomplishments for what came before!

AN EXPERIENCED STAFF

Continuing our trend for good teacher retention, we began the year with an experienced and gifted staff. Importantly, our most qualified teachers – our head teachers – all stayed on from last year. The classrooms rang with the voices of happy friends and our curriculum was lively and effective. In the Preschool, we tend to measure our success by the quality of experience of our children. Still, it is worth noting that our acceptances at competitive private schools are excellent as we provide both an organic learning experience and strong preparation for kindergarten. Several of our Pre-K children also qualified for Gifted and Talented programs, which must be determined through testing. Our qualified and creative staff has never been more able to ensure that every child is joyfully meeting their potential.

GIFT MEMBERSHIPS

While the demographics in our school were very similar to last year, the family relationship to BHS shifted when we offered a free year of membership to new Preschool families. Our percentage of children from member families went from 30% to over 50% and we saw that, as hoped, these families were highly engaged in community activities and religious services. We had hoped to evaluate the success of this program in several ways – one of which was the tendency of these families to begin a paid membership in their second year. It will be necessary to recalibrate considering the upheaval (both financial and geographical) of COVID-19. But the initial experience of offering this opportunity to call BHS “my synagogue” instead of “the synagogue” showed that families with young children are often eager to engage in Jewish community and need only some encouragement to begin their membership sooner.



FUNDRAISING

The annual Book Fair was not only financially successful in meeting its goals, but was truly an enjoyable family event! Our Spring Fundraiser “BHS Preschool Is Blooming” met the challenge of a March date with aplomb! Our usual date is May, which allows us to invite new families enrolled for the next school year and get them involved. Our committee offered reduced tickets to these new families who had only enrolled within a few days of the event and their turnout was high. We were able to come quite close to the levels of giving in a year we hold the event in May, as a result.

MORE FOR YOUNG FAMILIES

The Parenting Center also had excellent enrollment in its on-going classes, the Boker Twos and Shalom Yeladim. With the addition of a full-time Assistant Director, Lisa Kopel, we

have also been able to meet the strong interest in community-building activities in creative collaboration with

The Preschool is also offering evening parent support groups and held a Curriculum Night to inform parents about how to get the most from these new classes. The Parenting Center is also Zooming with its students and offering the usual schedule of parent/child events like a Pajama Havdalah, Tot Shabbat, and a parent-only Trivia Night.

The Preschool also worked with the Chesed Committee to create a Book of Rainbow Wishes for BHS members who were isolated by COVID-19. Both parents and children embraced this chance to share their wishes of caring and support.

COVID-19'S IMPACT AS WE LOOK AHEAD

Sadly, we have had to cancel our summer programming as the purpose of summer is quite different from school and the hours of fun, physical recreation we generally provide are not practical in a remote format. However, we are in the process of developing a Summer Subscription option so that our children can stay in touch with one another over the summer, our new students can begin to meet one another and their teachers, and we can provide a menu of fun summer-at-home options like "Sock-er" (safe indoor soccer time), arts and crafts, drama, gymnastics, etc. Teachers will guide Zoom playdates and meet-ups, too.

There is no doubt this is an extraordinary time for the families we serve in the BHS Early Childhood Department. It has been challenging to meet the highly individual needs of so many families enduring a time of upheaval. Through creativity, sensitivity, and tremendous hard work, we are striving to provide not only connection, but continued growth and education to our dear children. While we can responsibly provide fewer hours of programming, teachers' hours have nearly doubled. They have learned new technology and re-created their professional practice in a matter of days. They are meeting both the educational and emotional needs of children and parents with a level of professionalism and care that is every bit as extraordinary as these times.

At present, we are waiting for word from parents who are enrolled for the 2020-21 school year as to their plans. We have informed them that the Preschool plans to move forward with a September opening in whatever form we can. We will be there for their children remotely or otherwise!

When Rabbi Lippe led our two Zoom Preschool Seders, the resonance of the final words of these bittersweet events was clear. "Next year in Jerusalem!" has never been so relevant a statement. We all look forward, with great longing, to the time we can be together again as a community in health and happiness.

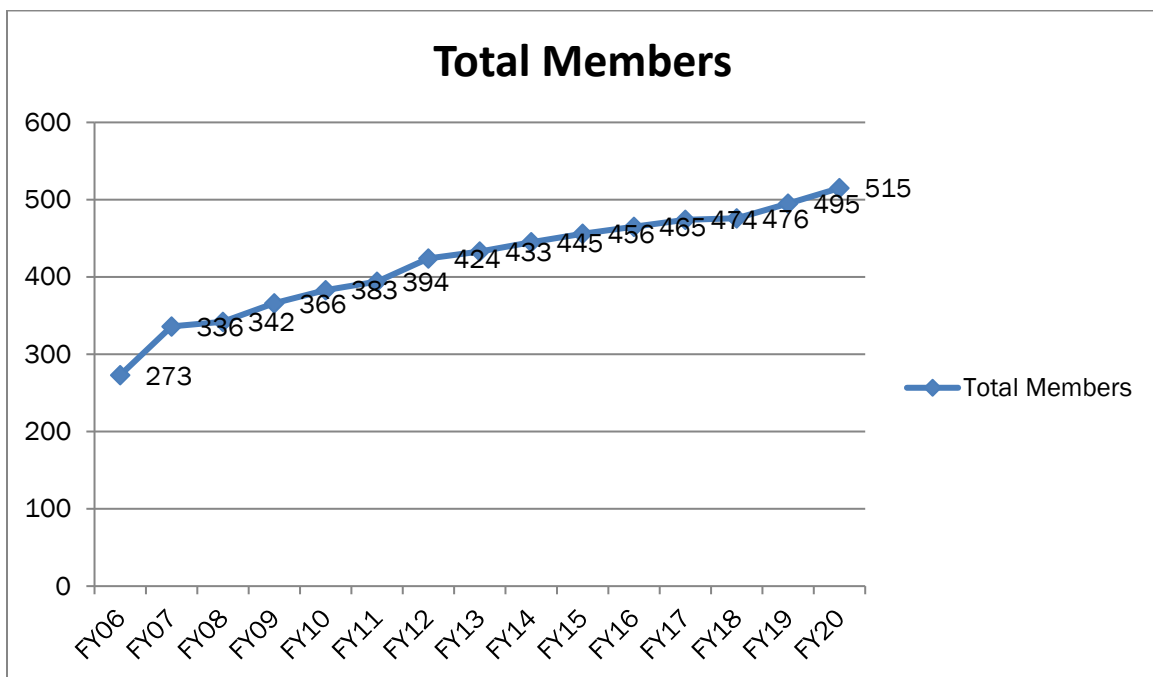

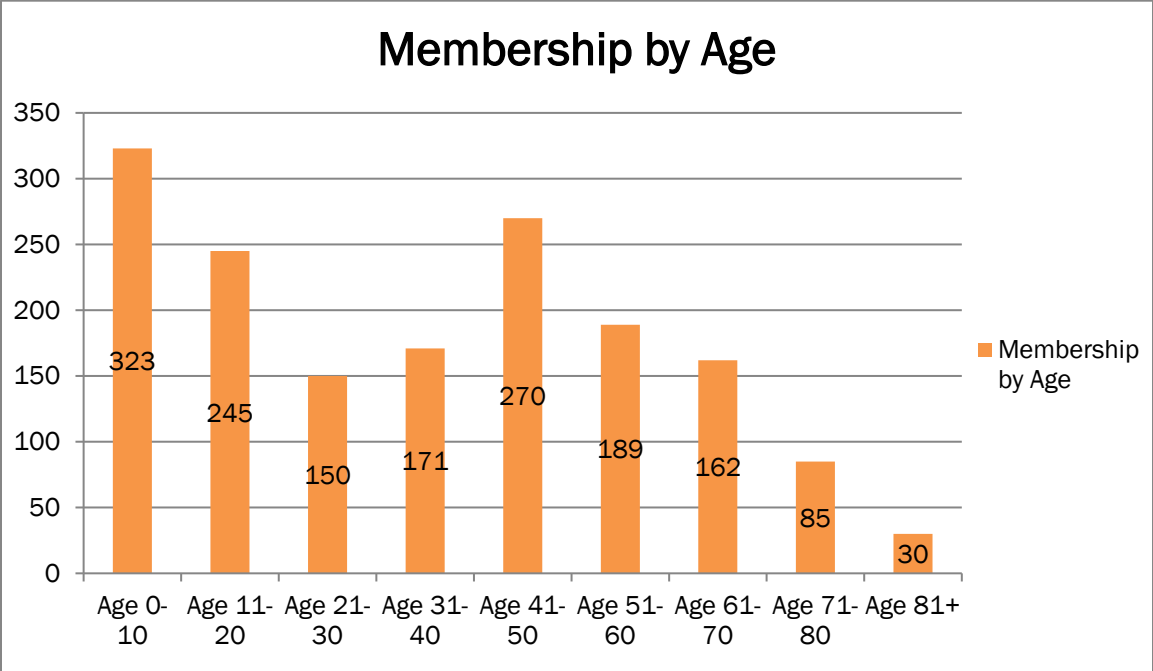

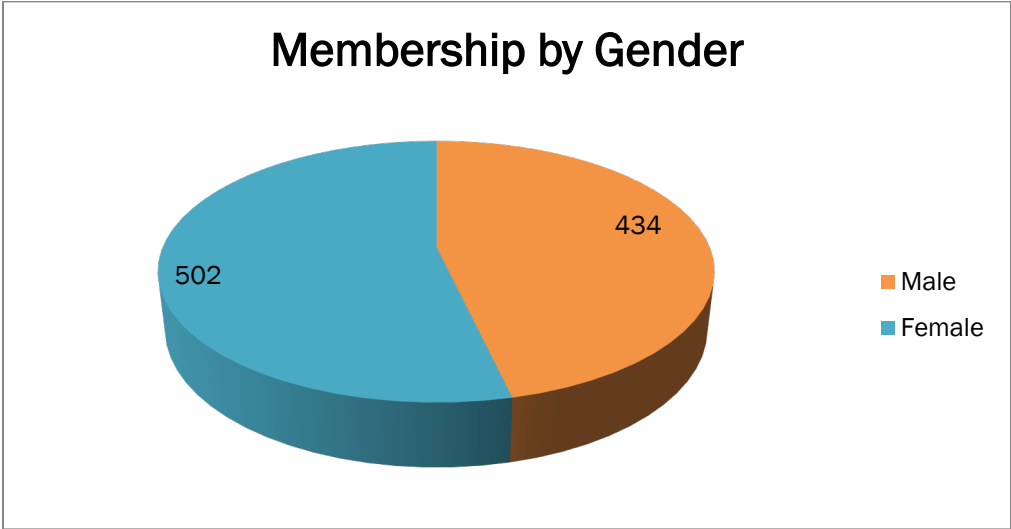
Membership by Age

The below graph breaks down the entire congregation, including children, by age. The largest age cohort in our congregation is children aged 0-10, noting our vibrant young families population at BHS.



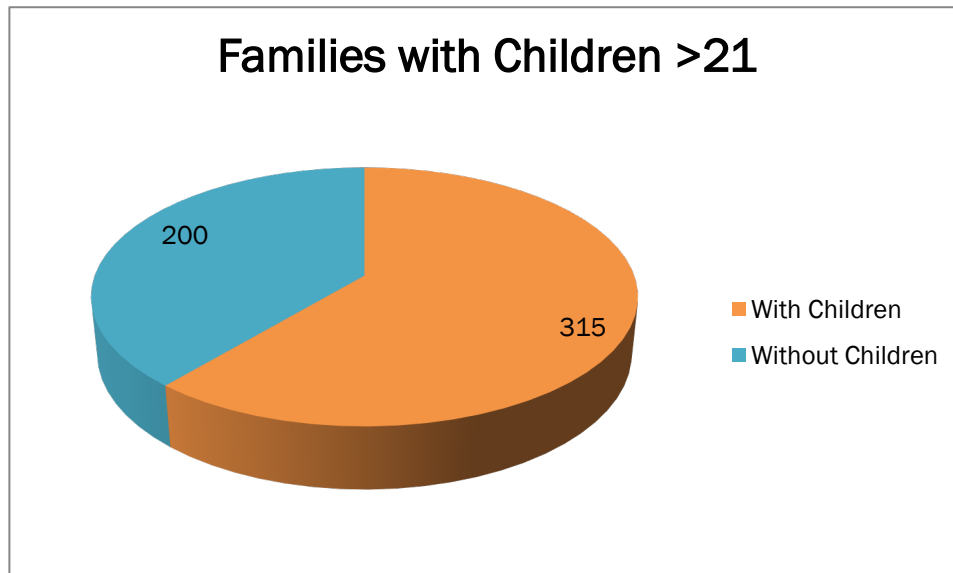
Membership by Gender

54% of the BHS adult membership is female and 46% of the adult membership is male. The below graph depicts individuals and not member units.



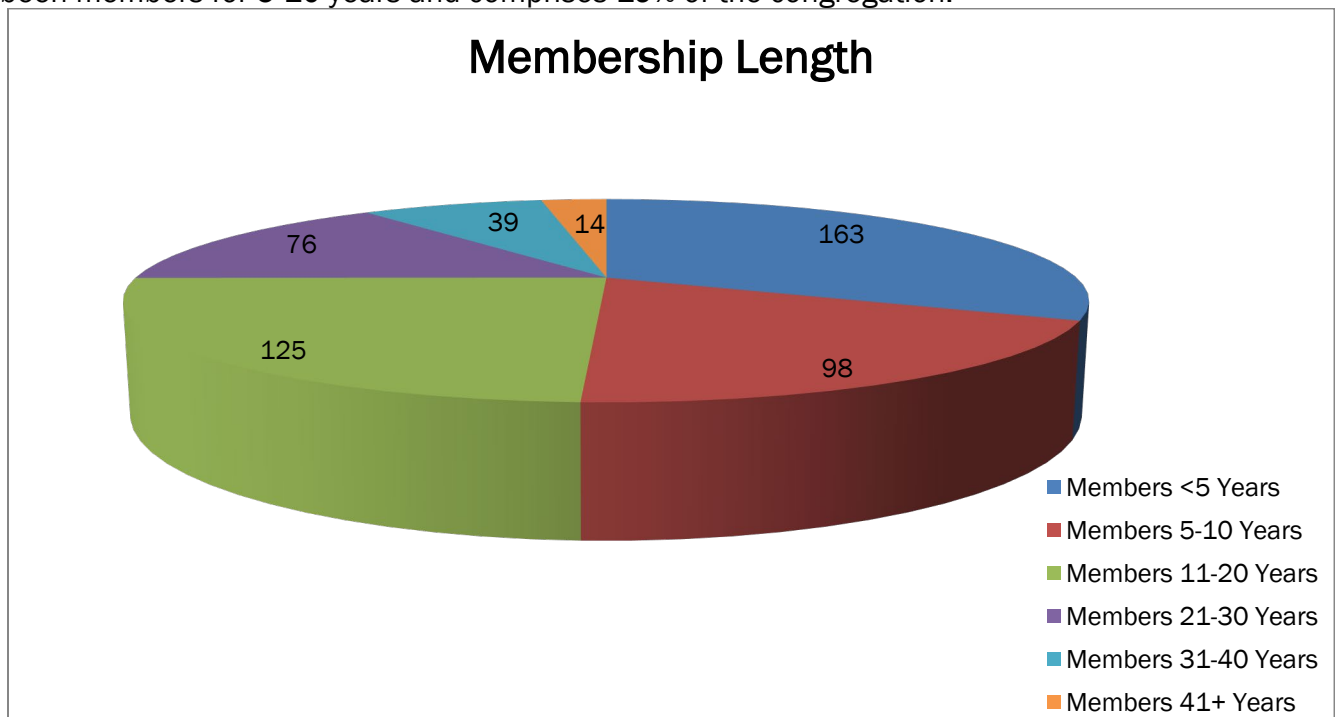
Families with Children Under 21

61% of the BHS congregation has children under the age of 21. The below graph depicts member units.



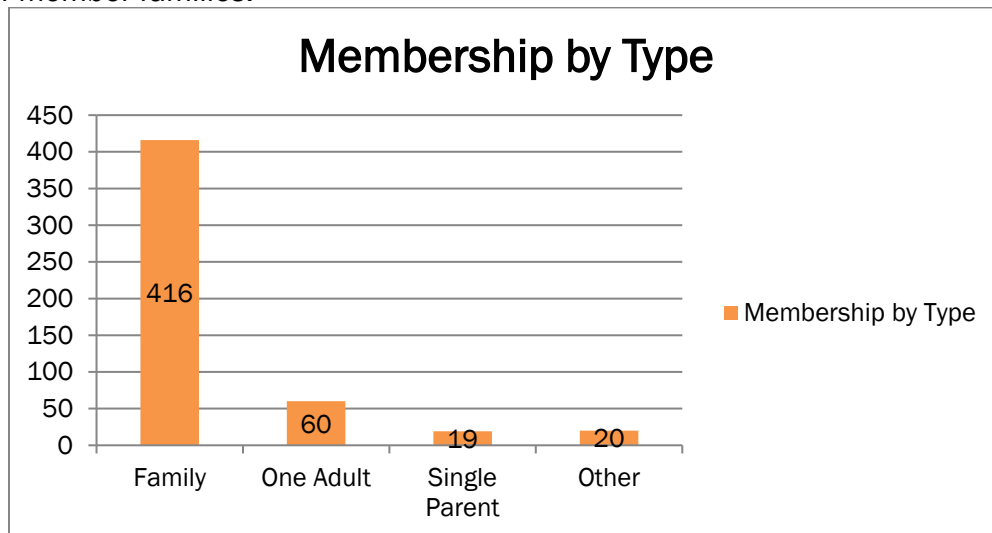
Membership by Tenure

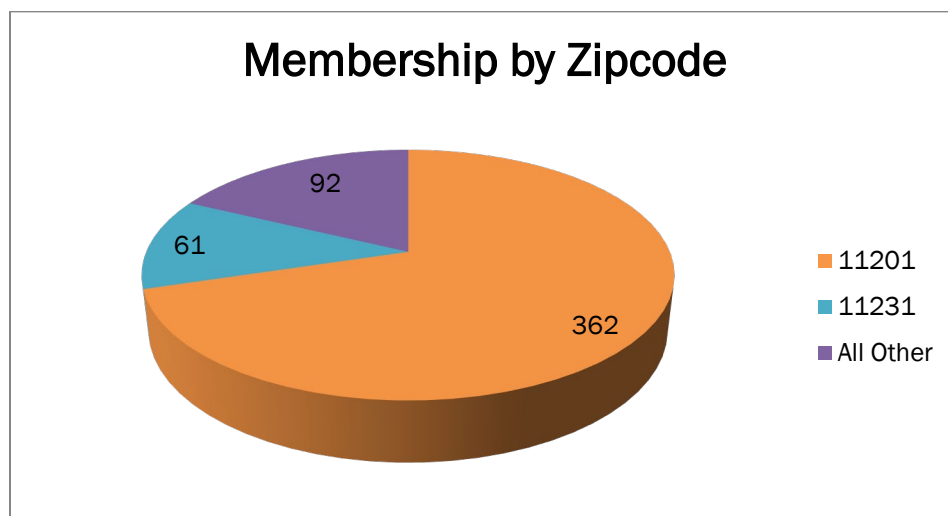
Membership by Type

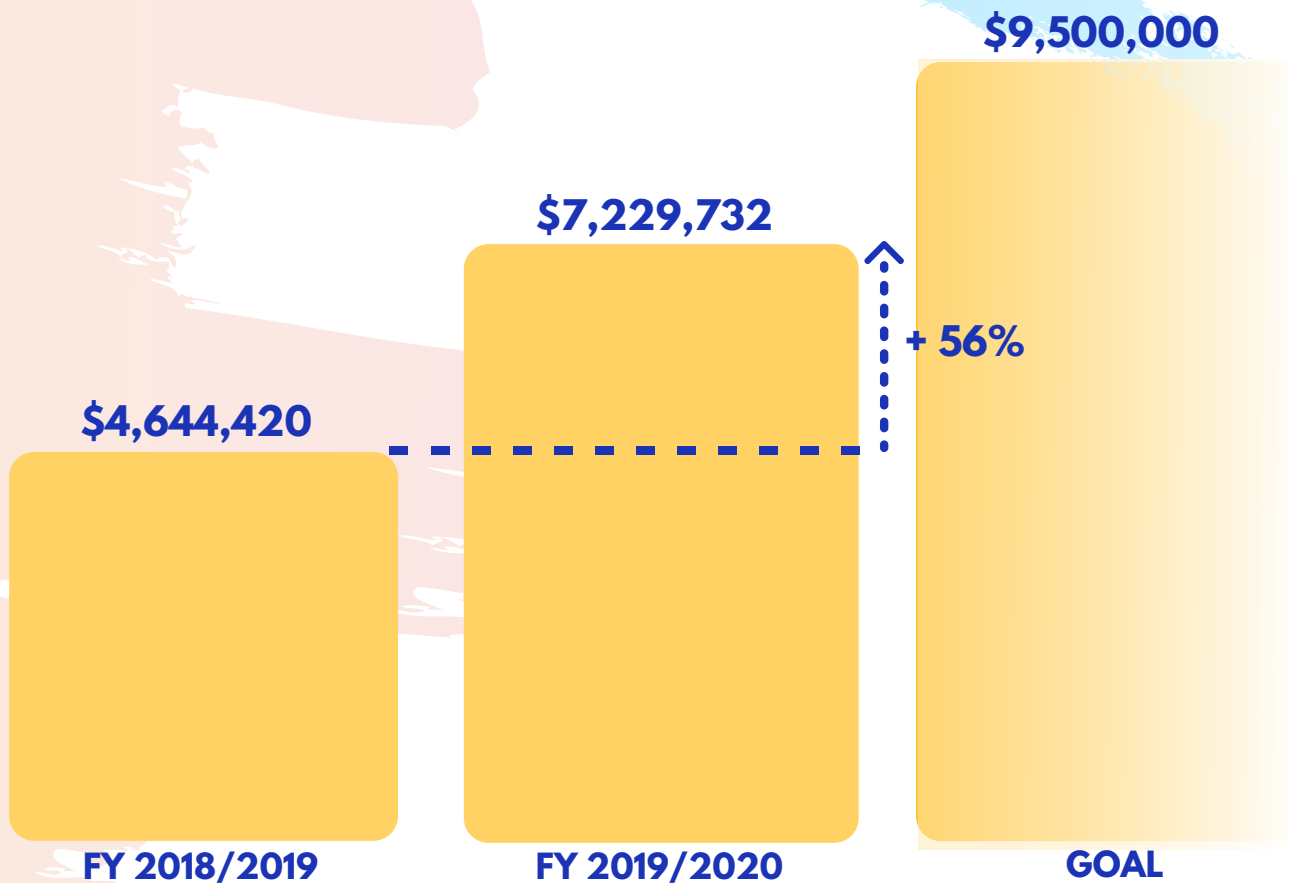

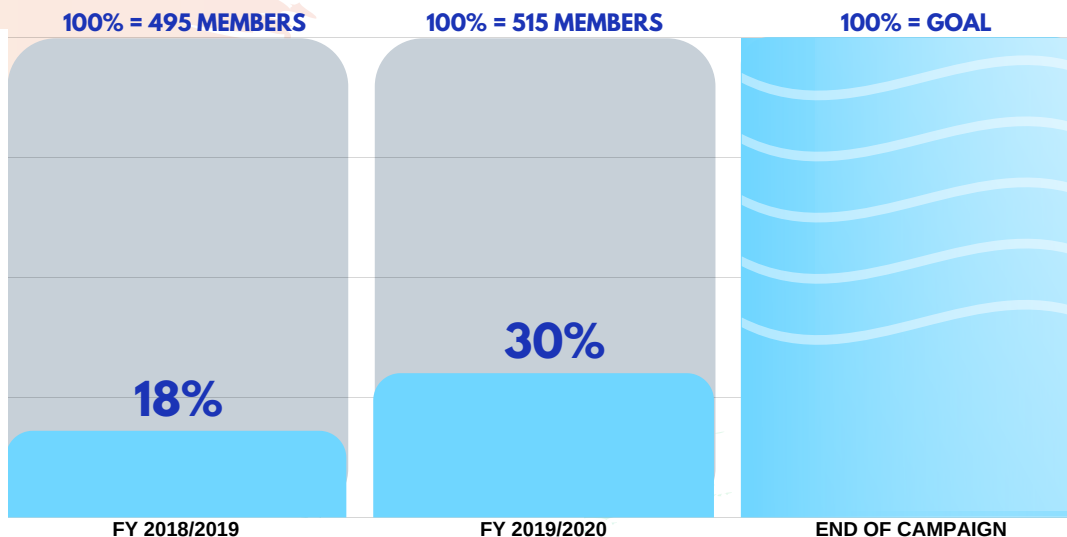


BHS NEW HEIGHTS CAPITAL CAMPAIGN
